ACT Standard and Jumpers

ACT 1 ACT1/ACT1J are entry level tests that are open to all dogs that have not earned a title in any AKC Agility class and that meet the age (15 months) and physical requirements for a regular AKC agility trial (Chapter 1, Section 3). Dogs must have two passing ACT1 scores to earn the ACT1 title. For ACT1J dogs must have two passing ACT1J scores to earn the ACT1J title. To receive the title certificate and have the title added to a dog's record, the dog must be registered/listed with the AKC.

ACT 2 (Standard)/ACT2J (Jumpers). ACT2/ACT2J are the second level Agility Course Tests that are open to all dogs that have dogs that have not earned a title in any AKC Agility class and that meet the age(15 months) and physical requirements for a regular AKC agility trial (Chapter 1, Section 3). Dogs must have two passing ACT2 scores to earn the ACT2 title. For ACT2J dogs must have two passing ACT2J scores to earn the ACT2J title. To receive the title certificate and have the title added to a dog's record, the dog must be registered/listed with the AKC.

Agility Course Tests are open to **all dogs fifteen (15) months of age or older** who have not earned any regular AKC Agility titles. Bitches in season are not eligible to enter. Dogs must be physically sound as described in Chapter 1, Section 3, Paragraph 7 of the Regulations for Agility Trials.

To acquire the title certificate and have the title added to a dog's record, the dog must be registered with the AKC. AKC Partner applications will be accepted at the test by the judge/evaluator and submitted with test results. Dogs that are not AKC registered/listed may participate and their performance will be recorded by the AKC under a temporary recording number. This temporary recording number will be e-mailed to the owner and must be used when entering subsequent ACT events and when the owner registers/lists the dog. Note: Temporary recording numbers may only be used to enter ACT events

Entries must be made on the **Official AKC Agility Course Test entry form** and must include the **AKC Agreement, completed fully, signed, and legible**. Entries may be declined, and dogs removed for disease, viciousness, or other cause.

All dogs must be on leash when on trial grounds except when in the designated warm-up area or competing on the course. No dogs may be left tied to trees, cars, fences, etc.

Order of Judging

ACT1 Standard, Rounds 1&2, ACT 1 Jumpers, Rounds 1&2

ACT2 Standard, Rounds 1&2, ACT 2 Jumpers, Rounds 1&2

Classes begin in the Standard Ring, moving to the Jumpers Ring after completion of the 2nd Standard round

Trial Site and Hours

Trial Site hours: 1:30pm until 30 minutes after the conclusion of judging.

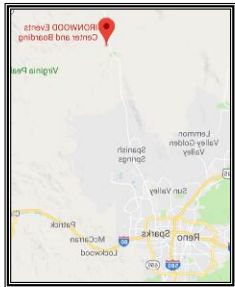
Briefing at 2:30pm. First Walk-through immediately to follow.

Judging (starting with ACT 1, round 1) to begin no earlier than 2:45pm

Directions to Site

The facility (Ironwood Events Center) is approximately 18 miles north of I-80 on Pyramid Way. It's an easy **20 minute** drive out the Pyramid Highway. You'll know you have arrived when you drive past the BLM wild horse holding pens on the east (right) side of the road. The Event Center is just north of the BLM holding pens. **DO NOT TURN ON IRONWOOD ROAD.** Go past Ironwood Road approximately ½ mile and turn right (east) onto Whiskey Springs Road. You really can't miss the facility; it is the large, red-roofed barn and is easily seen from the highway on the east side of the road.

From I-80 & Pyramid Way in Sparks: Go north on Pyramid Way 18 miles to Whiskey Springs Road, then turn right.



From Sacramento: Take I-80 East to the Pyramid Way off-ramp (at the Nugget). Turn left at the bottom of the ramp. Go north on Pyramid Way 18 miles to Whiskey Springs Road, then turn right.

From Carson City/Minden/Gardnerville via US 395: Take US 395/I-580 North to I-80 East. Take I-80 East to the Pyramid Way off-ramp (at the Nugget). Turn left at the bottom of the ramp. Go north on Pyramid Way 18 miles to Whiskey Springs Road, then turn right.

PARKING

Parking is available on the East side of the building, just past the outdoor arenas. The building entrance is across the drive from the outdoor arena.

Refunds

HEIGHT DIVISIONS

For the ACT program, ***dogs may run at any jump height (not to exceed 24 inches) as determined by the owner.*** There are no Preferred classes in ACT.

Use the following (from the AKC Agility Regulations) ***as a guide*** to determine the height you wish your dog to jump.

Regular	Preferred	
8 Inches	4 Inches	For dogs 11 inches and under at the withers.
12 Inches	8 Inches	For dogs 14 inches and under at the withers.
16 Inches	12 inches	For dogs 18 inches and under at the withers.
20 Inches	16 Inches	For dogs 22 inches and under at the withers.
24 Inches	20 Inches	For dogs over 22 inches at the withers.

Awards

A dark green qualifying ribbon will be awarded to all qualifying dogs. A title rosette will be available to all dogs achieving a new title. *All ribbons must be claimed the day of trial; no ribbons will be mailed.*

Course Familiarization

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training the dog.

Obstacles and Timing

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. Timing may be done with a Stopwatch or electronic timer (depending upon availability)

This event will be held indoors on dirt. Minimum ring size will be : 50' x 80'.

ACT 1 consists of 10-12 obstacles and includes the A-Frame (5 ft. height), Pause Table, Open Tunnel(s), and bar jumps. The panel jump, and tire jump MAY be used. Participants must complete the course in 60 seconds.

ACT 2 consists of 11-13 obstacles and includes the A-Frame (5 ft. height), Teeter, Pause Table, Weave Poles (6), Open Tunnel(s), Tire Jump, and Bar Jumps. The Dog Walk, Double Bar Jump, Panel Jump, Broad Jump, and/or Triple Bar Jump MAY be used. Participants must complete the course in 70 seconds.

ACT1 J consists of 10-12 obstacles and may include bar jumps, a panel jump, a tire jump, and tunnels. One bar jumps are required. Winged jumps will be used. Participants must complete the course in 50 seconds.

ACT2 J consists of 11-13 obstacles. Required obstacles include weave poles, a spread jump, and bar jumps. The course may include a panel jump, tire jump, and tunnels. Winged jumps will be used. Participants must complete the course in 60 seconds.

Ringside

Dogs may arrive any time prior to judging. Judges are not required to wait for dogs. The owner of the dog is solely responsible for being ready at ringside when it is time to be judged. The club has no responsibility for providing service through a public-address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. No refunds will be issued for absent or late teams.

Leashed Dogs

All dogs must be on leash when on trial grounds except when in the designated warm-up area or competing on the course. No dogs may be left tied to trees, cars, fences, etc. Please plan to use a crate for your dog.

ASSUMPTION OF RISK

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of TMDTC personnel or the Evaluator be asked to leave the show site. In such a case, no refund of any fees paid will be made. The **Truckee Meadows Dog Training Club Inc.** and **Ironwood Events Center**, and its agents, employees, etc., will assume **No** responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The **Truckee Meadows Dog Training Club Inc.** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **Truckee Meadows Dog Training Club Inc.**, **Ironwood Events Center** or any official thereof.

We are extremely fortunate to use this wonderful facility for our agility trials. In order to be able to continue using it, we have agreed that our exhibitors will cooperate with the following:

HORSES HAVE THE RIGHT OF WAY!

Even the best tempered horse can/will spook creating a potential for injury!

- *Keep dogs away from horses in the stalls, outdoor stalls, arenas, etc.*
- *Tarps, reflective covers, etc. are not allowed around the arena areas (including the small indoor arena North of the Trial area)*
- *If a horse(s) is in an arena, do not allow your dog to go near the arena or to be in an adjacent arena.*
- *Dogs are to be always leashed unless in the ring or in a designated off-leash warm-up area.*
- *Dogs are allowed in the arena area of the building, as well the crating areas. Dogs are not allowed in the downstairs lounge area, the Short Round Lounge upstairs, any restrooms or showers or the stable area.*
- *Exhibitors are NOT to use the dirt planters around the building to potty their dogs. (Please stay out of the dirt planters altogether.)*
- *Dogs are to be walked on leash to the bare dirt (think parking areas) or sagebrush areas to potty. .*
- *Do not allow your dog to potty on trash cans, buildings, or fencing.*
- *Please pick up after your dog. Buckets for waste will be on the grounds.*

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. AKC Canine PartnersSM applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the AKC Canine PartnersSM program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
